UPS Package Shipping Security Process Change

As you may have heard on the news, an explosive device detonated inside a FedEx facility in San Antonio, Texas on March 21st. Your safety and the safety of your local community is our primary concern.

Effective immediately, please begin following the temporary process below until further notice:

- When a customer brings a package into your location without a label, or with a handwritten label, you must ask the customer to open the package for a visual inspection of the contents.
- If you see or hear anything suspicious, report it immediately to local authorities.
- If the customer refuses to open their package for inspection, you must refuse the shipment.
- If you do not identify anything suspicious, you should then seal the package and ship as normal.

This does not apply to any drop-offs or packages you received prior to receiving this message.

Please know that UPS is cooperating with law enforcement authorities investigating the situation. During this time we ask you to use extra precaution when accepting packages and ensure you are following the security process listed above. If asked, do not speculate on the cause or nature of these incidents with customers.

Your safety and the safety of those around you is important. As always, please remember to:

- Follow the UPS ID check policy for all packages shipped from your location.
- Listen for **trigger terms** when processing shipments.
- If you see or hear anything suspicious, report it immediately to local authorities. Do not take any chances with your personal security or safety.

Make Sure That You Are Using The PEC/UPS Labels... Correctly

When processing a package using PEC's Total System UPS Certified Ready software, the last step is printing the shipping label. The UPS shipping label you produce from your Total System shipping software is intended to only be used when it is placed on a package at your store and it is shipped from your store. As you can see on the label below your store information is the return address – due to you being the shipper and not your customer.

the originating address. You, as the shipper, are expected to be the package gate keeper. You must physically see the package you are shipping, and have the opportunity to inspect the package, to make sure you are not shipping something dangerous and/or prohibited. The next step is to assess it, put your eyes on it to make or suggest adjustments to the packing quality based on the nature of the item itself, shipment method, or value if needed.

The very first question our Total System Software asks you is the “package contents.” If your label is not placed on a package in your possession leaving your store all bets are off. Anything you know to be true about the transportation or coverage of the package is voided. Claims for loss and/or damage would, of course, not be covered and the liability of illegitimately producing labels for unknown shipments is frightening. Don't let this happen at your PEC “Package Processing & Shipping Center.”

According to 2018 UPS® Tariff/Terms and Conditions of Service – United States, Updated December 24, 2017...

Packages may not have a value of \$5,000.00 or more if delivered or shipped to a UPS Access Point location or a value of \$1,000.00 or more if dropped off as pre-paid UPS packages.



The Tech Corner

AD-WARE – The Good, Bad and Ugly

Most of us are probably familiar with downloading free software that suites our particular needs. It could be something for productivity such as a word processor, a web browser, or a pdf reader. Maybe you enjoy playing games on your computer- there are many, many free games available. In fact, there are thousands upon thousands of free programs that we can download online and install onto our computers.

The fact that there are so many different programs available for free is great, but it also raises the question as to how they generate revenue if they distribute their program(s) for free? Writing programs and applications takes an investment of time, money, energy, and effort. These programs are offered for free, but in most cases are bundled with additional software, known as adware. This automatic bundling is the method in which they generate revenue. Most programs offer an “easy install” option as well as an “advanced install” option. These terms might seem a little confusing to some people, but the difference between “easy install” and “advanced install” is usually that easy install automatically installs the additional, bundled software whereas the advanced option allows you to deselect the bundled software, thus ensuring it is not installed. Selecting the “advanced install” option is the best course of action as it will allow you to install the software you want, and keeps your hard-drive running faster by keeping the additional adware off of the machine.

In a lot of instances, these adware programs, once inadvertently installed, are added to the list of programs that automatically start and run each time your computer is powered on. People who find themselves in this type of situation experience a much slower machine, and may even assume that their computer is plagued with viruses. The reality is, however, that in a lot of instances these adware programs

can simply be uninstalled and any issues which were caused by the program or applications- such as annoying pop up boxes - would then cease to exist.

There are many people who even take their computers to repair technicians and pay for this adware to be removed! Do not let this happen to you. Please, be aware of the “easy” install and “advanced” install options. When possible, always deselect any additional software that is bundled together when attempting to install the legitimate program you want. By following this simple procedure, you can help keep many unwanted programs and applications from being installed onto your machine. You save the system resources from being consumed and you allow your computer to function better by not loading the processor with additional tasks.

It is always best practice to read the prompts when you are installing software because the applications will attempt to bundle additional software in

most instances if the program is being downloaded free of charge, and it will inform you and allow you the option to not install

the additional program(s). If you already have bundled software installed- in which case millions of people do- simply going to “uninstall or change a program” in Windows allows you to uninstall any and all applications that you wish to remove. Going through this list and removing software you do not use and are unfamiliar with- such as games that get bundled with legitimate productivity software- is a great method to clean out your pc and make it run much better.
